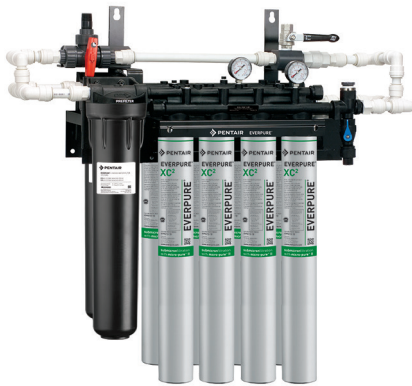

INSTALLATION TIPS

Choose a mounting location suitable to support the full weight of the system when operating.

Never use saddle valve for connection.

Use 3/4" water line.

Install vertically with cartridges hanging down.

Allow 2 1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.

Flush cartridges by running water through system for five (5) minutes at full flow.

OPERATION TIPS

Change cartridges on a regular six (6) month preventative maintenance program.

Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).

Service flow rate must not exceed 13.36 gpm (50.57 Lpm).

Always flush the filter cartridge at time of installation and cartridge change.

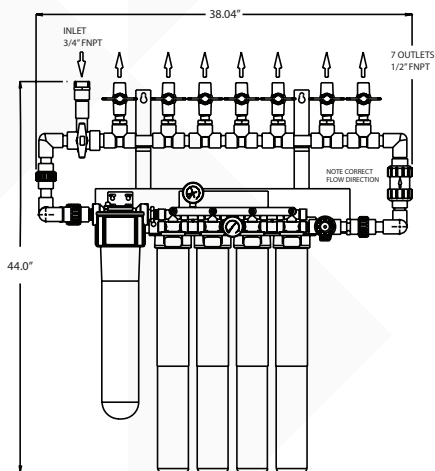
